VILLAGE ASSOCIATION MEETING FRIDAY, MARCH 6, 2020, BETHESDA THEATER DRAFT MINUTES¹

- 1. Chair Charlie Scott, called the meeting to order at 2:00 p.m., Friday, March 6, 2020.
- 2. <u>Chaplain Pat Spears</u> offered the invocation prayer.
- 3. <u>Secretary Bill Marlowe</u> announced the draft minutes of our last meeting on December 6, 2019 were published about mid-December 2019. He inquired whether there were any comments and/or questions. There being none, he asked for a motion to approve the draft minutes. A motion was made and seconded. The motion was unanimously approved.

 - b. Food and Beverage Director, Steve Ray, shared with members his role in Food and Beverage. He announced he has promoted Chelsea McCaw to Supervisor, noting she is an excellent baker. He pointed out a new menu called Bistro Express is being offered. It is a limited menu that staff can get to you in a short period of time, for example: a turkey sandwich, a salad with protein choices, and a couple of hot items that are ready to go. He commented there are some exciting new menu items coming to the 1912 Bistro, and the menu will include calorie information. - c. Wellness Center Director Annie Shaffer updated members regarding on-going construction for our new Wellness Center.
